This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to your usage of **FG Innovations Ltd Websites, Digital Interfaces and Apps**.

This privacy policy applies between you, the User of this Website, Digital Interface or App, and **FG Innovations Ltd**, the owner and provider of these elements.

FG Innovations Ltd, are the creators of ParadropVR. Frontgrid is a trading name of **FG Innovations Ltd**. We take the privacy of your information very seriously.

Please read this privacy policy carefully.

Definitions and interpretation

1. In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to FG Innovations Ltd via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);
Data Protection Laws	any applicable law relating to the processing of personal Data, including but not limited to the GDPR, and any national implementing and supplementary laws, regulations and secondary legislation;

2. In this privacy policy, unless the context requires a different interpretation:
 - a. the singular includes the plural and vice versa;
 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it.
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

3. This privacy policy applies only to the actions of FG Innovations Ltd and Users with respect to this Websites, Apps and Digital Interfaces. It does not extend to any websites that can be accessed from those listed including, but not limited to, any links we may provide to social media websites.
4. For purposes of the applicable Data Protection Laws, FG Innovations Ltd is the "data controller". This means that FG Innovations Ltd determines the purposes for which, and the manner in which, your Data is processed.

Data collected

 - h. gender

 - j. financial information such as credit / debit card numbers which are used by our partner payment providers
 - k. IP address (automatically collected)
 - l. web browser type and version (automatically collected)
 - m. operating system (automatically collected)
 - n. a list of URLs starting with a referring site, your activity on these Websites, Digital Interfaces and Apps, and the site you exit to (automatically collected)

In each case, in accordance with this privacy policy

How we collect Data

6. We collect Data in the following ways:
 - a. data is given to us by you ;
 - b. data is received from other sources; and
 - c. data is collected automatically.

Data that is given to us by you

7. FG Innovations Ltd will collect your Data in a number of ways, for example:
 - a. when you contact us through the Websites, Apps and Digital Interfaces, by telephone, post, e-mail or through any other means
 - b. when you register with us and set up an account to receive our products/services/newsletters
 - c. when you complete surveys that we use for research purposes (although you are not obliged to respond to them)

9. We will receive Data about you from the following publicly available third-party sources:
 - a. industry association lists
 - b. contact directories
 - c. online desk research

Data that is collected automatically

10. To the extent that you access the Websites, Apps and Digital Interfaces, we will collect your Data automatically, for example:
 - a. we automatically collect some information about your visits to our Websites, Apps and Digital Interfaces. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
 - b. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on our Websites, Apps and Digital Interfaces, see the section below, headed "Cookies".

Our use of Data

11. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our website, apps and digital interfaces. Specifically, Data may be used by us for the following reasons:
 - a. internal record keeping. improvement of our products / services
 - c. transmission by email of marketing materials that may be of interest to you
 - d. contact for market research purposes which may be done using email, telephone, fax or mail. Such information may be used to customise or update our Websites, Apps and Digital Interfaces in each case, in accordance with this privacy policy.

14. For the delivery of direct marketing to you via e-mail, we'll need your consent, whether via an opt-in or soft-opt-in:
 - a. soft opt-in consent is a specific type of consent which applies when you have previously engaged with us (for example, you contact us to ask us for more details about a particular product/service, and we are marketing similar products/services). Under "soft opt-in" consent, we will take your consent as given unless you opt-out.
 - b. for other types of e-marketing, we are required to obtain your explicit consent; that is, you need to take positive and affirmative action when consenting by, for example, checking a tick box that

we'll provide.

Who we share Data with

16. We may share your Data with the following groups of people for the following reasons:
- a. Our ParatropVR Venues, so they can tell you about events and offers around ParatropVR.com as well as other activities at their venue
 - b. Any of our group companies or affiliates - to facilitate and optimise your experience
 - c. our employees, agents and/or professional advisors - to facilitate and optimise your experience
 - d. third party service providers who provide services to us which require the processing of personal data - to facilitate and optimise your experience
 - e. third party payment providers who process payments made over these Websites, Digital Interfaces and Apps - to facilitate and optimise your experience
 - f. digital advertising providers including LinkedIn, Meta (Facebook and Instagram), You Tube, X, Google ads In each case, in accordance with this privacy policy.

Keeping Data secure

We will use technical and organisational measures to safeguard your Data, for example:

- a. access to your account is controlled by a password and a username that is unique to you. Please note we reserve the right to change usernames or delete accounts which have usernames some people may find offensive.
 - b. we store your Data on secure servers
 - c. payment details are encrypted using SSL technology (typically you will see a lock icon or green address bar (or both) in your browser when we use this technology

19. Data retention

20. Unless a longer retention period is required or permitted by law, we will only hold your Data on our systems for the period necessary to fulfil the purposes outlined in this privacy policy or until you request that the Data be deleted.
21. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

Your rights

22. You have the following rights in relation to your Data:
 - a. **Right to access** - the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
 - b. **Right to correct** - the right to have your Data rectified if it is inaccurate or incomplete.
 - c. **Right to erase** - the right to request that we delete or remove your Data from our systems.
 - d. **Right to restrict our use of your Data** - the right to "block" us from using your Data or limit the way in which we can use it.
 - e. **Right to data portability** - the right to request that we move, copy or transfer your Data.
 - f. **Right to object** - the right to object to our use of your Data including where we use it for our legitimate interests.

Transfers outside the United Kingdom and European Economic Area

26. Data which we collect from you may be stored and processed in and transferred to countries outside of the UK and European Economic Area (EEA). For example, this could occur if our servers are located in a country outside the UK or EEA or one of our service providers is situated in a country outside the UK or EEA. We also share information with our group companies, some of which are located outside the UK or EEA.
27. We will only transfer Data outside the UK or EEA where it is compliant with data protection legislation and the means of transfer provides adequate safeguards in relation to your data, e.g. by way of data

transfer agreement, incorporating the current standard contractual clauses adopted by the European Commission.

Data provided by Users will, where it is relevant to any part of our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this privacy policy, be permitted to use the Data for the purposes for which it was originally supplied to us.
31. We may also disclose Data to a prospective purchaser of our business or any part of it.
32. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

Cookies

33. Our Websites, Apps and Digital Interfaces may place and access certain Cookies on your computer. FG Innovations Ltd uses Cookies to improve your experience of using its Websites, Apps and Digital Interfaces and to improve our range of products and services. Type of Cookie	Purpose

If any court or competent authority finds that any provision of this privacy policy (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.
44. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
45. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
